1. **STATUTORY INFORMATION**

Penny Lane Store Ltd is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

The presentation currency of the financial statements is the Euro (€).

2. **ACCOUNTING POLICIES**

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The financial statements have been prepared in EUR. The values has been converted at an exchange rate of 1.0000 GBP = 1.1511 EUR.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Foreign currencies

Assets and liabilities in other currencies are translated into EUR at the rates of exchange ruling at the balance sheet date. Transactions in other currencies are translated into EUR at the rate of exchange ruling at the date of transaction. Exchange differences are taken into account in arriving at the operating result.

Going concern

The director has expressed his intention to provide sufficient funds to the company as and when needed to enable it to continue operating and to meet its liabilities as they fall due. On this basis, the director considers it appropriate to prepare accounts on the going concern basis. The accounts do not include any adjustments that would result should continuing finance cease to be made available.
