NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2022

1. General information

ENIC Group is an unlimited company incorporated in England and Wales. Its registered office is Lilywhite House, 782 High Road, London, N17 OBX.

The company was dormant (within the meaning of section 480 of the Companies Act 2006) throughout the year ended 31 December 2022. The company has not traded during the year or during the preceding financial year. During these periods, the company received no income and incurred no expenditure and therefore made neither profit nor loss.

The financial statements are presented in Sterling (\pounds) , which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £.
