#### 1 Statutory information

Format Extend Limited is a private company, limited by shares, registered in England and Wales, registration number 08166449. The registered office and principal place of business is 152 Coles Green Road, London, NW2 7HD.

#### 2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

#### 3 Accounting policies

These financial statements for the period from 1 October 2016 to 31 March 2017 are the first financial statements that comply with FRS 102 Section 1A Small Entities. The date of transition is 1 January 2016.
