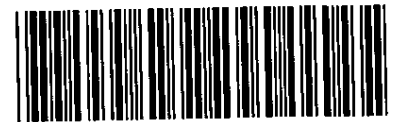

therefrom or the conclusion of the claim against the company by any other means.

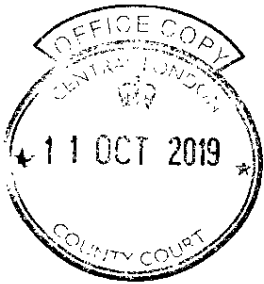
