

AND UPON READING THE PAPERS RECORDED ON THE COURT FILE AS HAVING
BEEN READ:

IT IS ORDERED that:-

1. The Applicants have leave to make a composite application in respect of the insolvency proceedings identified in the Schedules A to L to this Application (Schedules);

2. The proceedings listed in the Schedules, in so far as there are currently proceedings in any County Court or any District Registry in England & Wales other than the Manchester District Registry, be transferred to the Manchester District Registry solely for the purpose of considering and, if thought fit, making the orders listed below;
3. The Applicants do ensure that a sealed copy of every order transferring any case to this Court and of every order which may be made as a result of this application be lodged with the Court having jurisdiction over each case affected by such order for filing on the Court file relating to that case;
4. The time for service of this application be abridged to permit the application to be heard at such a time as this Court shall think fit;
5. Paragraphs 6 to 29 of this Order to take effect from midnight on 31 December 2017;
6. Pursuant to Section 108 of the Insolvency Act 1986 (the "Act") Mark Beesley (the Respondent) be removed from his office as Liquidator of the companies identified in Schedule A, being in Creditors' Voluntary Liquidation;
7. Pursuant to Section 108 of the Act, Tracy Mary Clowry (the 1st Applicant) and Gareth Hunt (the 2nd Applicant) be appointed as Joint Liquidators of the companies identified in schedule A being in Creditors' Voluntary Liquidation, to act jointly and severally with each other;
8. Pursuant to Section 108 of the Insolvency Act 1986 (the "Act") Mark Beesley (the Respondent) be removed from his office as Joint Liquidator of the companies identified in Schedule B, being in Creditors' Voluntary Liquidation;
9. Pursuant to Section 108 of the Act, the 2nd Applicant be appointed as Joint Liquidators of the companies identified in schedule B being in Creditors' Voluntary Liquidation, to act jointly and severally with the existing Joint Liquidator;
10. Pursuant to Section 108 of the Act the Respondent be removed from his office as Joint Liquidator of the companies listed in Schedule C being in Members' Voluntary Liquidation;

11. Pursuant to Section 108 of the Act, the 2nd Applicant be appointed as Joint Liquidator of the companies identified in schedule C being in Members' Voluntary Liquidation, to act jointly and severally with the existing Joint Liquidator;
12. Pursuant to Section 172(2) of the Act and Rule 12.36(2) of the Insolvency Rules 2016 (the "Rules") the Respondent be removed from his office as Liquidator of the companies listed in Schedule D, being subject to a Compulsory Winding Up Order;
13. Pursuant to Section 168(3) & (5) of the Act and Rule 12.36(2) of the Rules the 1st Applicant and the 2nd Applicant be appointed as Joint Liquidators of the companies identified in schedule D being subject to a Compulsory Winding Up Order, to act jointly and severally with each other;
14. Pursuant to Section 172(2) of the Act and Rule 12.36(2) of the Insolvency Rules 2016 (the "Rules") the Respondent be removed from his office as Joint Liquidator of the companies listed in Schedule E, being subject to a Compulsory Winding Up Order;
15. Pursuant to Section 168(3) & (5) of the Act and Rule 12.36(2) of the Rules the 2nd Applicant be appointed as Joint Liquidator of the companies identified in schedule E being subject to a Compulsory Winding Up Order, to act jointly and severally with the existing Joint Liquidator;
16. Pursuant to paragraph 90 of Schedule B1 to the Act and Rule 12.36 of the Insolvency Rules 2016 (the "Rules") the Respondent be removed from his office as Joint Administrator of the companies listed in Schedule F, being in Administration;
17. Pursuant to paragraph 91 of Schedule B1 to the Act and Rule 12.36 of the Rules the 2nd Applicant be appointed as Joint Administrator of the companies identified in schedule F being in Administration, to act jointly and severally with the existing Joint Administrator;
18. Pursuant to Section 7(5) of the Act the Respondent be removed from his office as Joint Supervisor of the company voluntary arrangement identified in schedule G;

19. Pursuant to Section 7(5) of the Act the 2nd Applicant be appointed as Joint Supervisor of the company voluntary arrangement identified in schedule G, to act jointly and severally with the existing Joint Supervisor;
20. Pursuant to Section 7(5) of Schedule 1 of the Insolvent Partnership Order 1994 the Respondent be removed from his office as Supervisor of the partnership voluntary arrangement identified in schedule H;
21. Pursuant to Section 7(5) of Schedule 1 of the Insolvent Partnership Order 1994 the 1st Applicant and the 2nd Applicant be appointed as Joint Supervisor of the partnership voluntary arrangement identified in schedule H, to act jointly and severally with each other;
22. Pursuant to Section 7(5) of Schedule 1 of the Insolvent Partnership Order 1994 the Respondent be removed from his office as Joint Supervisor of the partnership voluntary arrangement identified in schedule I;
23. Pursuant to Section 7(5) of Schedule 1 of the Insolvent Partnership Order 1994 the 2nd Applicant be appointed as Joint Supervisor of the partnership voluntary arrangement identified in schedule I, to act jointly and severally with the existing Joint Supervisor;
24. Pursuant to Section 298 of the Act and Rule 12.36(2) of the Rules the Respondent be removed from his office as Trustee in Bankruptcy of the individuals listed in Schedule J, being in bankruptcy;
25. Pursuant to Section 298 and 303(2) of the Act and Rule 12.36(2) of the Rules, the 1st Applicant and the 2nd Applicant be appointed as Joint Trustees in Bankruptcy of the individuals listed in Schedule J attached hereto, to act jointly and severally with each other;
26. Pursuant to Section 298 of the Act and Rule 12.36(2) of the Rules the Respondent be removed from his office as Joint Trustee in Bankruptcy of the individuals listed in Schedule K, being in bankruptcy;
27. Pursuant to Section 298 and 303(2) of the Act and Rule 12.36(2) of the Rules, the 2nd Applicant be appointed as Joint Trustees in Bankruptcy of the individuals listed in

Schedule K attached hereto, to act jointly and severally with the existing Joint Trustee in Bankruptcy;

28. Pursuant to Section 263(5) of the Act the Respondent be removed from his office as Supervisor (or Nominee where relevant) of the individual voluntary arrangements identified in Schedule L;
29. Pursuant to Section 263(5) of the Act the 1st Applicant and the 2nd Applicant be appointed as Joint Supervisors (or Joint Nominees where relevant) of the individual voluntary arrangements identified in Schedule L attached hereto, to act jointly and severally with each other;
30. The creditors of the companies and the individuals listed in the Schedules be notified of the Order by advertisement in the London Gazette within 14 days of receipt of the Order by the Applicants and at the time of the next statutory reporting requirement for each case;
31. Pursuant to paragraph 98 of Schedule B1 to the Act, Section 7(4) of Schedule 1 of the Insolvent Partnership Order 1994 and Section 263(4) of the Act, the Respondent be discharged from liability in respect of any action of his as administrator of the companies or supervisor of the companies, the partnership and the individuals listed in Schedule F, G, H, I and L with effect from 28 days after the relevant notice referred to in paragraph 29 above has been advertised, save in respect of any claim notified to the Respondent or the Applicants, by that date;
32. Pursuant to Rule 7.69, Rule 6.33 Rule 5.14 and 10.83 of the Rules the Respondent shall be at liberty to apply to the Secretary of State for his release, as Liquidator (whether voluntary or compulsory) or Trustee in Bankruptcy of the companies and individuals listed in Schedules A, B, C, D, E and J with effect from 28 days after the relevant notice referred to in paragraph 29 above has been advertised, save in respect of any claim notified to the Respondent or the Applicants, by that date;
33. The Applicants shall notify the Secretary of State of the Order as soon as reasonably practicable after it is made;
34. All creditors of the companies and the individuals listed in the Schedules do have permission to apply to the Court, on notice to the Applicants, within 28 days of being given notice of the terms of the Order, for the purposes of applying to vary or discharge

the order in so far as it affects the company or companies or individual's estates of which they are a creditor;

35. Pursuant to Rule 18.7 and Rule 1.3 and Schedule 5 of the Rules, the time for filing of the progress report in the creditors' voluntary liquidations of the companies listed in Schedules A and B be extended to the date of the next scheduled report in each case;
36. Pursuant to Rule 18.7 and Rule 1.3 and Schedule 5 of the Rules, the time for filing of the progress report in the members' voluntary liquidations of the companies listed in Schedule C be extended to the date of the next scheduled report in each case;
37. Pursuant to Rule 18.8 and Rule 1.3 and Schedule 5 of the Rules, the time for filing of the progress report in the compulsory liquidation of the companies listed in Schedule D and E be extended to the date of the next scheduled report in each case;
38. Pursuant to Rules 18.6 and Rule 1.3 of the Rules, the time for the filing of the progress report in the administration of the companies listed in Schedule F be extended to the date of the next scheduled report;
39. Pursuant to Rule 18.3 and Rule 1.3 of the Rules, the time for the filing of the progress report in the bankruptcy of the individuals listed in Schedule J and K be extended to the date of the next scheduled report;
40. Rule 3.65 of the Rules is overridden and dis-applied by Chapter 1A, of Part 6A of the Rules;
41. There be no order as to costs, save that the Applicants' costs of this application in the sum of £4,500 plus VAT, plus the Court fee of £155, and the London Gazette fee to advertise the Order which is estimated at £1,000 plus VAT, be charged as a cost or expense of the estates listed in the Schedules (each estate to bear an equal share, or such other share as the Applicants may decide but with no estate having to bear an amount exceeding 10% of the value of the available funds in the estates as at the date of this Order);
42. Immediately upon this order taking effect, any cases listed in the Schedules which, pursuant to paragraph 2 above are transferred to the Manchester District Registry be transferred back to the County Court or District Registry from which they originated;

43. Compliance with Rule 12.38(3) of the Rules is varied so that the lodging of a certified copy of this Order, once sealed, with each Court is deemed to be compliant with that Rule;

44. Rule 4(5)(b) of the Insolvent Companies (Report on Conduct of Directors) Rules 1996 (SI 1996/1909) shall (if but for this order it would apply) not apply and the Respondent is not required to submit any reports in respect of any of the voluntary liquidations listed at Schedule A;
