## **1 Introduction**

- 1 1 Following the appointment of myself and my partner, James Bradney, as Joint Administrators of the above named Company on 11 January 2007, I now provide you with our Final Administration Report
- 1 2 I enclose Form 2 24B together with an account of our receipts and payments for the period ended 11 December 2007 in accordance with Rule 2 47 of the Insolvency Rules 1986
- 1 3 In accordance with paragraph 100 (2) of Schedule B1 to the Insolvency Act 1986 the functions of the Administrators are to be exercised by any or all of them

## **3. Summary of Joint Administrators' Proposals**

- 3 1 At the meeting of creditors held on 15 March 2007 to consider the Joint Administrators' Proposals the following resolutions were proposed and unanimously passed,
- To continue to realise the Company's property
  - That under Rule 2 106 of the Insolvency Rules 1986 as amended (the Rules), that remuneration of the Joint Administrators be fixed by reference to time properly spent by them and their staff in attending to matters arising from the Administration In accordance with Statement of Insolvency Practice No 9 issued by the Association of Business Recovery Professionals the Joint Administrators be authorised to draw remuneration as and when funds are available on account of their time costs
  - That the Joint Administrators continue to manage the affairs of the Company and do all such things and generally exercise all of their powers as contained in Schedule 1 of the Act, as they consider desirable or expedient to achieve one or more of the statutory purposes of the Administration
  - That if there are insufficient funds to make a distribution to unsecured creditors, the Administration will be ended by the dissolution of the Company as per paragraph 84 of Schedule B1 of the Insolvency Act 1986

- That if it transpires that a distribution to unsecured creditors is possible and the Joint Administrators believe it should be made by the Company in Liquidation then the Joint Administrators will file a notice in respect of the Company together with a final progress Report with the Registrar of Companies in order that the Administration will cease and the Company will move automatically into Creditors' Voluntary Liquidation ("CVL") Should the Company move into CVL it is proposed that the Joint Administrators be appointed as Joint Liquidators of the Company or, such different person(s) as are nominated by the creditors in accordance with paragraph 83(7) of Schedule B1 to the Act and Rule 2.117(3) of the Rules, provided that such nomination is made after the receipt of these proposals by the creditors and before the proposals are approved
  - That if it transpires that a distribution to unsecured creditors is possible and the Joint Administrators believe it should be made by the Company in Administration, it is proposed that the Joint Administrators make an application to Court, under section 65(3), so allowing the Joint Administrators to make the distribution Once all assets of the Company have been realised, and a distribution made to unsecured creditors (in the event that there are sufficient realisations to make such a distribution), the Joint Administrators propose filing notices pursuant to paragraph 84 of Schedule B1 to the Act together with their final progress Report at Court and with the Registrar of Companies for the dissolution of the Company The appointments will cease to have effect following the registration of the notices by the Registrar of Companies
  - The Joint Administrators will be discharged from liability in respect of any action of them as Administrators under paragraph 98(3) of Schedule B1 to the Insolvency Act 1986 fourteen days after their appointment as Joint Administrators of the Company ceases to have effect
  - The Creditors' Committee previously formed comprised the following members shall be re-appointed
    - 1 Ms Ann-Marie Cousins
    - 2 Miss Gurinder Lall
    - 3 Mr Michael Liebermann
    - 4 Mr Shabbir Master
    - 5 Mr Raymond Needham
  - That the books and records of the Company be stored for one year after the dissolution of the Company
- 3.2 Please note that according to Paragraph 83 (8)(f) of Schedule B1 of the Insolvency Act 1986, any creditors' committee which is in existence immediately before the company ceases to be in Administration shall continue in existence after that time as if appointed as a liquidation committee
- 4 Progress of Administration**
- 4.1 I refer to my Report and Statement of Proposals dated 26 February 2007 and my Progress Report dated 10 July 2007 that contained information on the Company's financial position, details of the Joint Administrators' time analysis and Receipts and Payments account I do not propose to repeat the contents of these Reports
- 4.2 Attached is my Receipts and Payments Account for the period from 11 January 2007 to 11 December 2007

- 4.3 We have continued our extensive investigation into the actions of the Directors, with the assistance of our legal advisors
- 4.4 We have subsequently reached an agreement with Mr Scott to place all of the charged properties on the market with a view to continuing to realise the equity therein for the benefit of the creditors in the Liquidation. To date a total of £46,086 has been realised from completed sales of Mr Scott's properties
- 4.5 As you will note from the attached Receipts and Payments Account there currently are enough funds to facilitate a distribution to unsecured creditors. However the Joint Administrators believe that a distribution should be possible once actions against the Directors have been completed and additional funds have been received. Hence they will file a notice of the Company moving from Administration to CVL together with the Final Progress Report
- 4.6 No other nominations were received and therefore, in accordance with Rule 2.117 of the Insolvency Rules 1986 our appointment as Joint Liquidators will take effect from the date of acknowledgement of the Notice of move from Administration to CVL at Companies House

#### **5 Joint Administrators Remuneration**

- 5.1 I have attached a summary of the time costs incurred by this office from 11 January 2007 to 11 December 2007. To date, time costs incurred by this office total £19,060 for 109 hours, at an average of £175 per hour. Disbursements have totalled £2,299. To date we have not drawn any office holders' fees in respect of these time costs
- 5.2 The office holders' fees drawn are in respect of time costs incurred and approved in the prior Administration period of 14 November 2005 to 13 November 2006. This remuneration was approved by the creditors on 23 January 2006 and is in accordance with paragraph 99 (3) of Schedule B1 of the Insolvency Act 1984

#### **6 Outstanding Issues to be dealt with in the Liquidation**

- 6.1 The investigation into causes of the failure of the Company will continue. The ongoing investigations will be focused on the actions of the Directors. Sprecher Grier Halberstam LLP will assist the Joint Liquidators in their investigations
- 6.2 Any rights of action that have been identified by the Joint Administrators shall continue to be pursued by the Joint Liquidators. This will include a full investigation into the various possible antecedent transactions as per the Insolvency Act 1986. Should any creditors be aware of any matters pertaining to the above or any other matter, please send the relevant details to this office as soon as possible
- 6.3 The Joint Liquidators will also seek to agree all the claims of the creditors in order to facilitate a distribution. To date I have received formal claims from preferential and unsecured creditors totalling £7,885 and £1,143,622. I attach a list of creditors including details of their claims. Should your claim not be shown as advised on this list please can you complete the attached proof of debt form and provide us with the necessary supporting documentation
- 6.4 The EC Regulation on Insolvency Proceedings does apply in this case and these proceedings will be Main Proceedings as defined in Article 3 of the EC Regulation
