



The Sheriff, having resumed consideration of the foregoing petition and having seen the Edinburgh Gazette dated 28 August 2019 and The Herald newspaper dated 30 August 2019, each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court,

(1) Finds that the amount of the share capital of the said J.E. Cockayne Limited paid up or credited as paid up does not exceed £120,000, that the said company is unable to pay its debts and that the said company has by special resolution resolved that the company be wound up by the court;

(2) Orders that the said company, having its registered office at 16 Flakefield, East Kilbride, Glasgow, G74 1PF be wound up in pursuance of the Insolvency Act 1986;

(3) Nominates and Appoints Blair Carnegie Nimmo and Alistair McAlinden, both of KPMG Limited, 319 St Vincent Street, Glasgow, G2 5AS, as joint interim liquidators of the said company with the usual powers and authorises then to advertise their appointment in the Edinburgh Gazette and The Herald Newspaper in lieu of sending out notices to creditors and others in terms of rule 4.18(4) of the Insolvency (Scotland) Rules 1986;

(4) Finds the petitioner entitled to the expenses of the application and Directs same to be expenses in the liquidation.
