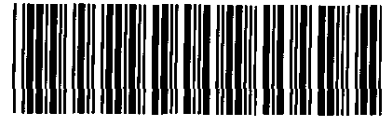

**UPON THE APPLICATION OF DAN MINDEL** (whose contact details are Ernst & Young LLP, 1 More London Place, London, SE1 2AF, dmindel@uk.ey.com and whose address for service is Pinsent Masons LLP, 3 Hardman Street, Manchester, M3 3AU) made in his capacity as outgoing liquidator in respect of the matters listed in the Schedules hereto by notice dated 27 April 2017

**AND UPON READING** the documents recorded on the Court file as having been read

**IT IS ORDERED THAT:-**

**1. APPLICANT'S REMOVAL AS OFFICE HOLDER**

- 1.1 The Applicant be removed as office holder in the cases set out in the Schedules hereto pursuant to Section 108 of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016 with effect from the date of this Order.

2. **APPOINTMENT OF OFFICE HOLDERS**

- 2.1 Richard Barker, having filed a statement with the Court that he is qualified to act as an insolvency practitioner and that he consents to act, be appointed in substitution for the Applicant as joint liquidator with Samantha Keen for the matters set out in Schedule 1 from the date of this Order.
- 2.2 Richard Barker, having filed a statement with the Court that he is qualified to act as an insolvency practitioner and that he consents to act, be appointed in substitution for the Applicant as joint liquidator with Angela Swarbrick for the matters set out in Schedule 2 from the date of this Order.
- 2.3 Richard Barker, having filed a statement with the Court that he is qualified to act as an insolvency practitioner and that he consents to act, be appointed in substitution for the Applicant as joint liquidator with Elizabeth Anne Bingham for the matters set out in Schedule 3 from the date of this Order.
- 2.4 In the matters set out in the Schedules hereto any act required or authorised under any enactment to be done by a liquidator may be done by all or any one of the respective liquidators in each matter acting jointly or alone.

3. **ADVERTISEMENT, REPORTING TO MEMBERS AND RELEASE**

- 3.1 As soon as reasonably practicable, and in any event within 28 days of the date of this Order, the Applicant shall procure that a block advertisement is placed in the London Gazette. The advertisement shall contain notification of the removal of the Applicant from the cases identified in the Schedules hereto and the appointment of the relevant Respondent in his place and shall be in substitution for notifying each individual member and creditor on each estate, save to the extent provided for at paragraph 3.2 below.
- 3.2 The Respondents shall at the first convenient opportunity, and in any event when the next routine report is due to the members of each estate or within twelve months following the making of this Order, whichever is sooner, notify such members of the making of this Order, such notice to contain the following matters:-
- 3.2.1 an explanation of the effect of this Order; and
- 3.2.2 express reference to the liberty to apply contained in paragraph 4 below.
- 3.3 In relation to the cases listed in the Schedules hereto, insofar as there is any requirement for any appointment or removal of an office holder to be advertised, the requirement shall be dispensed with save to the extent provided for in paragraph 3.1 above.
- 3.4 Without being required to apply to the Secretary of State for a release pursuant to any relevant provision, the Applicant shall be granted his release in respect of each case on

the later of 28 days after the publication in the London Gazette referred to in paragraph 3.1 above or 28 days after receipt of any of the notices directed to be sent under paragraph 3.2 above in respect of that case.

**4. LIBERTY TO APPLY TO THE COURT**

4.1 There be liberty to each member of each estate set out in the Schedules hereto to apply to vary or discharge this Order within 28 days of receipt of the notices directed to be sent under paragraph 3.2 above.

**AND IT IS HEREBY FURTHER ORDERED:-**

**5. SERVICE**

5.1 The notice period for service of the Application required under Rule 12.9(3) of the Insolvency (England and Wales) Rules 2016 be abridged.

5.2 The Order be served on the Secretary of State to whom there be express liberty to apply.

5.3 The Applicant file any appropriate notices in respect of his removal and replacement and those appointments in accordance with this Order with the Registrar of Companies within the prescribed times or otherwise within a reasonable period from the date of this Order.

**6. COSTS**

6.1 The costs of this Application be borne by Ernst & Young LLP.
